**Thematic areas of the conference:**

**Section 1. “Improving public management in the field of transport safety”**

- development and implementation of state programs on traffic safety and coordination of use of all types of public transport;
- measures to reduce the mortality rate and severity of road accidents;
- social and economic losses from road traffic injuries and ways to reduce them;
- investigation of the causes of accidents and factors affecting the severity of their consequences.

**Section 2. “Regulatory and technical transport security”**

- bringing Ukrainian transport legislation in line with international standards;
- improving the level of road safety and road infrastructure;
- improvement of mechanisms of active and passive safety of cars;
- Increasing the level of safety of passengers and cargo transportation;

**Section 3. “Organizational and practical measures for qualitative change of behaviour of traffic participants”**

- training drivers and improving driving school activities;
- training specialists in transport safety, their education;
- psychological aspect of transport security;
- strengthening public awareness in the field of transport safety;
- teaching the traffic rules to certain categories (groups) of the population;
- advocacy of compliance with traffic rules;
- responsibility for traffic safety offenses;
- medical security of transport safety.
